- RID – for transportation by rail
- IMDG – for transportation by sea (worldwide)
- USDOT (49CFR) /AAR600 - for transportation by road and rail in the USA
- CSC & ISO 1496 – for container framework
- Pressure Vessel Design Codes (e.g. ASME, PD5500, AD-MERKBLATTER) – for the tank design and manufacture
- TC Impact Approved – testing for use on Canadian railroads
- UIC – registration for use on European railways
- LRCCS – to meet the requirements of the Lloyd's Register Container Certification Scheme

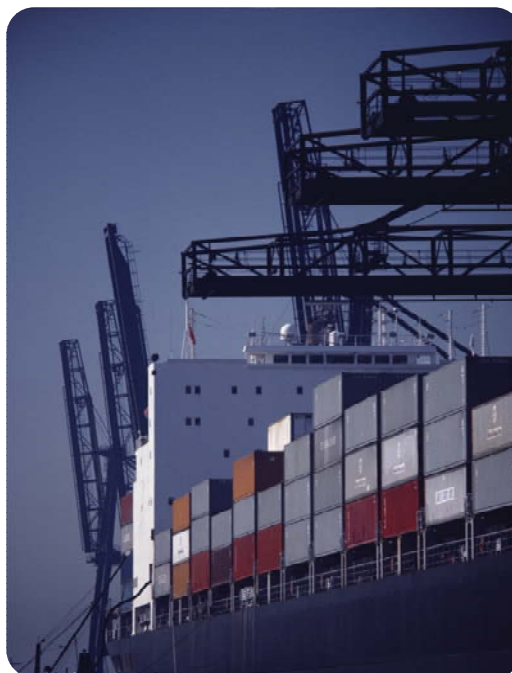
